

UNSIGNED LEAGUE

PLAYER PARTICIPATION AGREEMENT

This Player Participation Agreement (“**Agreement**”) is entered into by and between **Unsigned League**, an exposure basketball league affiliated with the Thailand Elite Basketball Association (“**TEBA League**”), and the undersigned individual (“**Player**”).

By registering, submitting payment, or participating in the Unsigned League, Player agrees to be legally bound by all terms of this Agreement.

1. PURPOSE OF THE UNSIGNED LEAGUE

The Unsigned League is an **exposure-based basketball platform** designed to simulate the professional playing environment of the TEBA League. Participation functions as an **extended tryout** opportunity only.

Unsigned League does **not** guarantee:

- Selection
- Roster placement
- Playing time
- Salary
- Professional contract

Unsigned League is **not** an employer, agent, or representative of the Player.

2. REGISTRATION FEE & NO REFUNDS

2.1 Registration Fee

Player agrees to pay the required Unsigned League registration fee prior to participation.

2.2 Strict No-Refund Policy

ALL PAYMENTS ARE **FINAL AND NON-REFUNDABLE**, including but not limited to situations involving:

- Injury
- Non-selection
- Schedule changes
- Travel issues

- Personal withdrawal
- Performance outcomes

Once payment is made, Player waives all rights to refunds, chargebacks, or payment disputes.

3. TRAVEL, HOUSING & TRANSPORTATION

3.1 Player Responsibility

Player is solely responsible for:

- International and domestic airfare
- Ground transportation
- Housing
- Meals and personal expenses

3.2 Return Flight Required

Player **must book a round-trip flight** prior to participation.

3.3 OPTIONAL HOUSING ASSISTANCE

Unsigned League may, at Player's request, connect Player with third-party local housing or real estate partners. Player acknowledges and agrees that:

- Housing assistance is **optional**
- Any housing arranged will be provided **at an additional cost**
- **Such cost will exceed the standard \$400 registration payment**
- Housing fees are separate from registration fees
- All housing fees must be paid **in full and in advance**
- Unsigned League does not guarantee housing availability, quality, safety, or location

Unsigned League bears **no liability** for housing disputes or conditions.

4. LEAGUE FORMAT & BENEFITS PROVIDED

Participation includes **only** the following:

- Three (3) official games
- In-game action photography
- Official statistics recorded via **FIBA LiveStats**

- Livestreamed games
- League-issued uniform
- Personalized jersey with Player name

There are **no practices**. Player evaluations occur **only during games**.

5. PLAYER SELECTION & CALL-UPS

5.1 Limited Advancement

Unsigned League anticipates approximately **three (3) to six (6)** Players total may advance to the TEBA League.

5.2 No Control Over Selection

Unsigned League has **no authority or influence** over:

- Player evaluations
- Team selections
- Contract offers

All decisions are made solely by TEBA League team owners and coaching staff.

5.3 Selection Criteria

Player acknowledges selections may be based on:

- Performance
- Team needs
- Positional fit
- Character and professionalism

These factors are **outside Unsigned League's control**.

6. NO GUARANTEE OF CONTRACT OR COMPENSATION

Participation does **not** guarantee:

- A professional contract
- Salary
- Roster spot
- Playing time

Unsigned League is a **platform only**, not a guarantor of employment.

7. TEBA LEAGUE CONTRACTS & PAY

7.1 Salary Requirement Upon Signing

If Player is selected and signs with a TEBA League team, that team is **required to pay Player a salary** pursuant to TEBA League rules.

7.2 Voluntary Free Play

If Player chooses to play without pay, such decision is:

- Entirely voluntary
- At Player's sole discretion
- Not required or encouraged by Unsigned League

Unsigned League bears no responsibility for such decisions.

8. FLIGHT CHANGE FEES

If Player is signed by a TEBA League team, team owners are required to pay a **percentage of Player's flight change fee**, pursuant to league policy. Player must still initially book a return ticket.

9. PAYMENT AUTHORIZATION & NO CHARGEBACKS

Player authorizes Unsigned League to charge the payment method provided for:

- Registration fees
- Housing fees (if elected)
- Administrative or league-related fees

Player agrees:

- Not to initiate chargebacks or disputes
- That chargebacks constitute a **material breach**
- That breach may result in removal, forfeiture, and permanent disqualification from Unsigned League and TEBA League opportunities

10. ROLE ACKNOWLEDGMENT

Player acknowledges they are:

- Participating **solely as a player**
- Not an evaluator, scout, agent, or decision-maker

Only TEBA League owners and coaching staff may evaluate or sign Players.

11. CODE OF CONDUCT

Player agrees to conduct themselves in a professional manner. Unsigned League reserves the right to remove Player, without refund, for:

- Unsportsmanlike conduct
- Harassment or abuse
- Criminal behavior
- Disruption of league operations
- Conduct detrimental to the league's reputation

12. ASSUMPTION OF RISK & LIABILITY WAIVER

Player assumes all risks associated with participation, including injury, illness, travel risks, and property loss, and releases Unsigned League, TEBA League, owners, staff, sponsors, and affiliates from all related claims, except where prohibited by law.

13. NO EMPLOYMENT OR AGENCY RELATIONSHIP

Nothing in this Agreement creates an employment, agency, partnership, or joint venture relationship.

14. GOVERNING LAW & VENUE

This Agreement shall be governed by and construed in accordance with the laws designated by Unsigned League. Venue shall lie exclusively in the jurisdiction selected by Unsigned League.

15. ENTIRE AGREEMENT

This Agreement constitutes the entire understanding between the parties and supersedes all prior representations, written or oral.

16. ACKNOWLEDGMENT & SIGNATURE

By signing below, Player confirms they have read, understood, and voluntarily agreed to all terms, including the **non-refundable nature of all payments**.
